2016 The Year that was at Myrtleford Lodge:

2016 has been a very busy year for us all at Myrtleford Lodge Aged Care with many residents coming and going, both Respite and Permanent Care Residents.

I have put together a summary of 2016 at Myrtleford Lodge.

Here is a summary for 2016:

We have seen 47 new residents, a mixture of both respite and permanent residents admitted to Myrtleford Lodge for varying lengths of stay - 28 permanent residents.

Myrtleford Lodge occupancy has been 97% for the 2016 year.

75% of our residents are female.

Currently the average age of residents is 86.4

We have 1 centenarian

33 new staff have commenced as part of our team in 2016

We currently employ 91 staff at Myrtleford Lodge

We have received 740 documented incidents.

We have received 38 documented improvements and suggestions

We have reviewed and updated 142 policies and procedures.

We have completed 70 audits on a full range of areas.

We have completed 28 quality activity reports.

Resident survey: satisfaction rate of 95% - which identifies a strong indication that the organisation is meeting the vast majority of needs.

Resident / Representative survey: satisfaction rate of 96% - outstanding result.

We have received and fixed thousands of maintenance requisitions.

Staff commitment to Myrtleford Lodge for 5 years or longer has been 17 in total and 11 staff members have achieved 10 years of service. • We have dished up countless meals to residents, visitors and staff from our kitchen, with all meals being prepared on site under the guidance from our visiting Dietitian. We have celebrated all of the residents birthdays during the year.

I would like to thank all the staff for their tireless work, humour, commitment to the residents and professionalism in the care and services they deliver. I know all the

residents appreciate your efforts.

We face many challenges every day and celebrate many occasions and although we may not get it right all the time, every effort is made to ensure the residents at Myrtleford Lodge are secure, happy and respected.

We thank all our external services such as hairdresser, volunteers, medical staff, allied health staff and contractors.

AUSTRALIA

The first recorded Australia Day celebrations were held on January 26, 1808 to mark twenty years since Captain Arthur Phillip raised the flag at Sydney Cove.

Australia Day

• Lachlan Macquarie was the first Australian Governor to hold the first "official" Australia Day celebrations in 1818, to mark thirty years of European settlement. The celebrations included a thirty gun salute and a ball at Government House.

• Australia Day was called "Foundation Day" in the early part of the nineteenth century, and was typically marked by sporting events including horse racing and boat races.

• The first colony to declare Australia Day as a public holiday was New South Wales in 1838, on the 50th anniversary of the Sydney Cove landing.

• By 1888 nearly all of the colonies had declared a public holiday to celebrate Australia Day, but it wasn't until the 1940's that January 26th was agreed upon by all states as the proper day to celebrate.

• The two animals featured on the Australian coat of arms are the Emu and the Kangaroo - the reason for this being that neither animal can walk backwards, but instead can always go forwards, symbolising Australia's desire to do the same.

Each month we are profiling some of the expected outcomes of the Accreditation Standards. This month we focus on Expected Outcome:

STANDARD 4.6 – FIRE, SECURITY AND EMERGENCIES

This expected outcome requires that:

Management and staff are actively working to provide an environment and safe systems of work that minimise fire, security and emergency risks.

This is some of the ways we actively seek to comply with this standard:

Emergency management includes identifying potential internal and external emergency risks, prevention strategies, emergency preparedness, emergency response, business continuity and recovery response. The overall objective of emergency management is to minimise injury to staff, residents, and visitors and damage to property during an emergency event.



Facility emergency planning occurs in conjunction with other agencies and where appropriate is aligned with the local, State/ Territory and national plans.

Emergency Management Plans for specific emergency events are developed with key stakeholder input, evaluated for effectiveness and annually reviewed for ongoing relevance.

These plans incorporate fire detecting and acting upon a fire risk, breaches of security and other emergencies.

Myrtleford Lodge fire alarm system is designed to detect heat or smoke and provide an automatic notification of a fire and its location. The fire detectors are wired to the fire indicator panel and fire bell.

Once a detector is activated:

- its location is shown on the fire indicator panel
- the fire bell commences to ring continuously
- a signal is sent automatically to the fire brigade and
- the emergency warning system is started in the ALERT mode. The system provides a loud signal throughout the building to warn staff of a fire.
- As each sprinkler is activated independently when the designated temperature is reached the number of sprinklers that become operational is limited to those close to the fire.

Monthly fire panel testing and fire detection system is conducted by an accredited external contractor.

Regular checks by an external contractor of the smoke doors and fire detectors are completed as well as the sound system for emergency procedures, sprinkler system and fire hydrant mains.

The entire facility is compartmentalized to reduce the need for external evacuation. This will be at the direction of the staff member in charge.

Emergency Procedure action plans are distributed around facility – at all phone points



All facility and resident's electrical equipment must be tagged and tested every 2 years so can you please advise maintenance or reception if you bring in new electrical equipment.

Fire and emergencies training scheduled regularly to ensure all staff attends an annual update.

Staff are trained to remember R-A-C-E when responding to a fire emergency:

- **R**escue remove anyone from immediate danger, if safe to do so, stay low and do not block corridors or exits.
- Alarm break fire alarm glass and ring 000 and ask for the Fire Brigade, notify staff in the area.
- Contain close windows and doors behind you, if safe to do so.
- Extinguish –attempt to extinguish the fire if trained and it is safe to do so.

Prepare to Evacuate (you will be instructed by the RN in charge only if required)

Resident evacuation lists are maintained with photographs of residents and mobility status. This is utilized in the event of an emergency evacuation.

Regular inspection checklists are conducted for every area. A summary of the inspection checklist is tabled at staff and OH&S committee meeting. The inspection checklists identify potential and actual hazards related to the physical environment. Inspection checklist involves checking of all emergency exits to ensure free from obstruction.

All emergencies that occur are reviewed with actions implemented to prevent further occurrences.
